<b>ENTRY FEES</b>	The cost for the entry fee is <b>60 EUR</b> per gymnast. At the time of the Nominative registration (by <b>13<sup>th</sup> March, 2025.</b> ) 100% of the entry fee must be paid to the OC. The entry fee is not refundable. Entries without payment of the entry fees will be considered as invalid and will be refused.  <b>(important note: Federations which choose <b>OPTION I</b> will not pay entry fees)</b>			
<b>ACCREDITATION</b>	An accreditation system will be set up upon arrival of the delegations at the competition venue. All officials and delegation members will need an accreditation to enter the training and competition halls.

<p><b>DRAWING OF LOTS/REPLACEMENT POLICY</b></p>	<p>The gymnasts' drawing of lots for all FIG Apparatus World Cup events will be managed electronically.</p> <p>If not possible, it will take place on site, during the orientation meeting or during a separate function organized for that purpose with invitation to all participating NFs. <b>ANTI-DOPING</b>	<u><b>Doping controls</b></u> Doping controls will be organised by the International Testing Agency (ITA) on behalf of the FIG and according to the World Anti-Doping Code (WADC), the international standards enacted by the World Anti-doping Agency (WADA) and FIG Anti-Doping Rules.  <u><b>Host federation WADC compliance</b></u> The exploitation of any rights related to the hosting of an event is subject, at all times, to the compliance with the WADC and the international standards enacted by WADA. Regardless of whether the event has already been allocated or not, the FIG may terminate any collaboration with the host federation or the LOC, immediately and without paying any penalty and/or compensation or incurring liability of any kind, under the following circumstances: (i) if the National Anti-Doping Organisation (NADO) in charge in the concerned country is declared non-compliant by WADA (ii) if the relevant country has been ruled ineligible to host the event. In such cases, the FIG is entitled to reassign the event to any other host federation in another country where the WADC and the WADA international standards are fully respected.

The Organizing Committee will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before <b>10<sup>th</sup> February 2025</b>. to the LOC.</p> <p>The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.</p>

In case a gymnast received a DNS/DNF during the Apparatus Finals, points will be awarded based on the Qualifications ranks.

If after application of the tie breaking rules outlined in the Technical Regulations, Section 2, there is still a tie, the points of the equal ranks will be added and divided by the number of ties.

Based on the Apparatus World Cup points assigned, separate men's and women's Apparatus World Cup Ranking Lists are established on each apparatus as follow:

<b>WINNER OF THE ANNUAL APPARATUS WORLD CUP SERIES</b>	<p>The winner of the annual Apparatus World Cup Series is the gymnast with the highest number of Apparatus World Cup points on the respective apparatus after the last event of the year, taking into consideration the best results (maximum 4), regardless of the number of competitions the athletes participated in. In case of a tie in ranks in the Apparatus World Cup Ranking List concerned, the tie will be broken by respecting the following criteria:</p> <ol style="list-style-type: none"> <li>a. The ranks of the max. four (4) counting exercises will be added and the gymnast with the lowest total prevails. Note: in case of a tie in the ranks to determine the four (4) counting exercises, the exercises with the highest final scores will prevail.</li> <li>b. If the tie remains, the final scores of the max. four (4) counting exercises will be averaged and the gymnast with the highest average prevails.</li> <li>c. If the tie remains, the total E-scores of the max. four (4) counting exercises (max. eight (8) scores for Vault) will be averaged and the gymnast with the highest average prevails.</li> <li>d. If the tie remains, the total D-scores of the max. four (4) counting exercises (max. eight (8) scores for Vault) will be averaged and the gymnast with the highest average prevails.</li> </ol> <p>Winners of the annual Apparatus World Cups Series will receive an additional prize money paid by the FIG as per Art. 10.2.
